ORDER

WHEREAS, the recognition was granted to the institution namely **Nisarga Institute of Education, Manasa Campus, Southern Extension, Kollegal-571440, Chamarajanagara District, Karnataka** run by **Manasa Educational Trust, Kollegal Chamarajanagar District, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/APSO2036/B.Ed/2004-2005/8873 dt. 30.11.2004 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, an affidavit from the institution was received by this office on 21.01.2015. The SRC revised order was issued to the institution on 18.05.2015.

3. **AND WHEREAS**, as per decision of SRC once again the agenda was placed before SRC 321<sup>st</sup> meeting. The SRC in its 321<sup>st</sup> meeting held during 28<sup>th</sup> – 30<sup>th</sup> September, 2016 considered the matter and decided to issue a letter. As per decision of SRC a letter was issued to institution on 16.11.2016. The institution submitted its reply to SRC on 01.12.2016. The SRC in its 329<sup>th</sup> meeting held during 06<sup>th</sup> & 07<sup>th</sup> February, 2017 considered the written representation and decided as under:-

1. The request is for reduction for B.Ed. course from 2 to 1 unit; and, for cancellation of the VT inspection.
2. The request is accepted.
3. They should the latest approved faculty list because the 2014 Regulations have changed the faculty norm.
4. There is no need of a fresh inspection.
5. We can issued the fresh FR under 2014 Regulations only after action as described above.

4. **AND WHEREAS** as per decision of SRC a letter was issued to institution on 14.02.2017. The institution has not submitted reply till date. The matter was considered by the SRC in its 375<sup>rd</sup> meeting held from 13<sup>th</sup> & 14<sup>th</sup> May 2019 and the Committee decided to issue show cause notice. As per the decision of SRC a show cause notice was issued to the institution on 16.05.2019. The institution did not reply to the show cause notice.

5. **AND WHEREAS** the SRC in its 381<sup>st</sup> meeting held on 31<sup>st</sup> Oct & 01<sup>st</sup> Nov, 2019 considered the matter and decided to issue Final Show Cause Notice to the institution. The institution vide letter dated 18.12.2019 submitted its reply to the show cause notice. The SRC in its 383<sup>rd</sup> meeting held on 07<sup>th</sup> to 09<sup>th</sup> considered the matter and decided as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the original documents and records submitted by the institution on 18.12.2019 in respect of Show Cause Notice. The Committee decided that the **continuation order be issued to Nisarga Institute of Education, Karnataka for B.Ed programme for 1 unit of 50 students.**

6. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Nisarga Institute of Education, Assessment No. 68 & 69, 7<sup>th</sup> Ward, Missamma Girls Home Building Road, Southern Extension, Kollegal-571440, Karnataka run by Manasa Educational Trust, Southern Extension Kollegal-571440, Karnataka** for continuation of recognition for B.Ed course of two years duration with an intake of 50 students (one unit) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

8. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:




- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter;
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
11. The institution shall make available the list of students admitted on its official website.
12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
